ASSIGNMENT OF MEMBERSHIP INTEREST

This Assignment of Membership Interest (this "Assignment") is made and entered into as of August 23, 2022 (the "Effective Date"), by and among (i) Toto Energy, LLC, a Delaware limited liability company (the "Company") (ii) Yorktown Energy Partners IX, L.P., a Delaware limited partnership ("Yorktown"), (iii) North Shore Energy, LLC, a Delaware limited liability company ("North Shore") and (iv) Roemer Interests, Ltd., a Texas limited partnership ("Roemer Interests") and Roemer Oil Company, a Colorado Corporation ("Roemer Company", and together with Roemer Interests, "Roemer") (each an "Assignor" and collectively, the "Assignors"), and (v) NEC Operating, LLC, a Texas limited liability company ("Assignee"). RECITALS

WHEREAS, Assignors own all of the issued and outstanding membership interests in the Company (the "Conveyed Interest").

WHEREAS, pursuant to that certain Membership Interest Purchase Agreement dated as of August 23, 2022 (the "**Purchase Agreement**"), by and among the Company, the Assignors, and the Assignee, the Assignee agreed to purchase from the Assignors, and the Assignors have agreed to sell to the Assignee, the Conveyed Interest pursuant to and in accordance with the terms and conditions therein.
