That the undersigned, LAMOYNE JACKSON and WANDA JACKSON, his wife, doing business as JAKE'S OIL COMPANY, hereinafter referred to as Assignor (whether one or more), for and in consideration of Ten and More Dollars (\$10.00), the receipt and sufficiency of which is hereby acknowledged, does hereby sell, assign, transfer and set over the full 100% working interest to the following persons and entities in the proportion set opposite each name, to-wit:

Arrowhead Exploration, LLC..... 20%

(JTWROS denotes ownership as joint tenants with rights of survivorship and not as tenants in common.)

hereinafter referred to as Assignees, in and to the Oil and Gas Lease described as follows:

Oil and gas lease dated June 23, 1983, from Patrick Wanker, et al., Lessors, to Big Creek Oil Operations, Lessee, recorded in Book A76, page 359, and all ratifications to the same, and covering the following described real estate in Trego County, Kansas, to-wit:

Northeast Quarter (NE/4) of Section Twenty-four (24), Township Eleven (11) South, Range Twenty-three (23) West.

This Assignment is made with all rights incident thereto, and personal property thereon, appurtenant thereto or used or obtained in connection therewith, but is subject to overriding royalties of record.

The Assignor covenants with the Assignee, their personal representatives, heirs and assigns, that Assignor is the lawful owner of and has good title to the interests above assigned in and to said lease, estate, rights and property, free and clear from all liens, encumbrances or adverse claims, that said lease is a subsisting lease on the land above described, and all rentals and royalties due thereunder have been paid and all conditions necessary to keep the same in full force have been duly performed, and that Assignor will warrant and forever defend the same against all persons whomsoever, lawfully claiming or to claim the same.

This Assignment shall be binding on and inure to the benefit of the Assignor and Assignees and their respective heirs, legatees, personal representatives, successors and assigns.
