ARTICLE I Grant and Habendum

Section 1.01 <u>The Grant</u>. For and in consideration of Ten Dollars (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby GRANT, BARGAIN, SELL, CONVEY, ASSIGN and DELIVER unto Assignee all right, title and interest owned by such Assignor at the Effective Time in and to the following (collectively, the "Properties"):
