In addition, Assignor does sell assign, transfer and set over unto Assignee all rights of way, easements, and all surface and down hole equipment, fixtures and other personal property located thereon or used in connection therewith wherever situated or located, including the salt water disposal well and equipment.

Further, Assignor warrants that it has good title to the oil and gas and salt water disposal leases which are the subject matter of this Assignment and that there are no unpaid bills or invoices that may give rise to the filing of a mechanic's lien.
