**LEGAL DESCRIPTION EXHIBIT "A" TO
JOINT TENANCY WARRANTY DEED ATTACHED**

TRACT ONE (1):

The NW 1/4 of Section 9, Township 27 South of Range 18 East in Neosho County, excepting therefrom the North 50 acres of said quarter section; also excepting therefrom a triangular tract of land lying west of U.S. Highway #59 in the NW corner thereof; also excepting therefrom the applicable portion of the following described tract of land, to wit: Commencing at the SE corner of said NW 1/4, thence West on South section line 13 feet; thence northeasterly to the NE corner of said quarter section; thence South on East line of said quarter section to the place of beginning, containing 108 acres more or less.

TRACT TWO (2):

Lots 1, 3 and 4 in Section 5, Township 27, Range 18, Neosho County, Kansas.

TRACT THREE (3):

Lot 6 in the E 1/2 of the NW 1/4 and Lot A West of the Public Highway in the West Half of the NE 1/4, and that part of Lot 5 in the S 1/2 of the NW 1/4, all in Section 4, Township 27, Range 18; also a strip 10 feet wide off the West side of the NW 1/4 of the SW 1/4, Section 4, Township 27, Range 18, Neosho County, Kansas.

TRACT FOUR (4):

The SW 1/4 of Section 4, Township 27, Range 18; and all that part of Lot 5 lying South of Neosho River, lying in the SW 1/4 of NW 1/4 of Section 4, Township 27, Range 18; and all of Lot 6 in said Section 4, Township 27, Range 18; and following described piece of land to wit: Commencing at a stone on right bank of Neosho River in the line between NE and NW quarters of said Section 4, thence South 13 chains and 40 links, thence East 10 chains, thence North 12 chains and 4 links to the right bank of Neosho River, thence West along said river bank to the place of beginning, containing 13 acres, more or less, and known as Lot "A" in the W 1/2 of the NE 1/4 of said Section 4, less the public road south and east of said Lot "A", and less that lot, parcel or piece of land now owned by A.
