KNOW ALL MEN BY THESE PRESENTS:

FOR ONE DOLLAR AND OTHER GOOD AND VALUABLE CONSIDERATIONS, receipt of which is acknowledged, Kenneth & Regina Laymon, LLC [hereinafter referred to as "Assignor"] hereby grants, bargains, sells, conveys, transfers, and assigns all of Assignor's working interest in and to the oil and gas leases described on the attached Exhibit B as follows:

One-half to Laymon Oil II, LLC; and

One-half to be divided equally between the following: Amy & Patrick McConaghie; Rachelle & Lukus Galemore; and Hana & Thad Trahan.

The lease interests assigned to the Assignees are subject to the terms of a separate Agreement between the Assignor and Assignees of the same date which grant first purchase option rights to certain parties and limit rights to partition of the interests. The McConaghie, Galemores and Trahans shall each hold their undivided one-third of one-half [this being 1/6] share of the working interest in the Leases as tenants in common, and each 1/6 share shall be held as joint tenants with right of survivorship between the spouses.

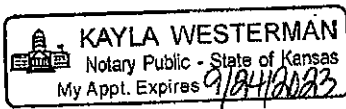
