**BILL OF SALE**

THIS BILL OF SALE is made between **QLXX, LLC** ("Seller") and **Black Rock Resources, LLC**, a Kansas Limited Liability Company ("Buyer").

WHEREAS, Seller wishes to sell and the Buyer wishes to buy all right, title and interest in and to all of the oil and gas personal property currently located on the NE/4 of 32-19S-20W Rush County, Kansas on the Jones G Oil and Gas Lease ("Lease"), including all wellbores, as described in Exhibit "A" ("Wells"), and equipment, as described in Exhibit "B" ("Personal Property").

NOWHEREFORE, for good and valuable consideration paid by Buyer to Seller on or before delivery of this Bill of Sale, the receipt and sufficiency of which is acknowledged, the Seller grants, sells, assigns, transfers and conveys to Buyer the Wells and Personal Property, subject to the following terms and conditions:

1. Seller covenants, warrants and represents that:
  - (a) it has good and marketable title to the Wells and Personal Property, free and clear of any mortgage, charge, security interest, lien, claim, charge or other encumbrance of any nature or kind whatsoever; and
  - (b) it has the authority to sell the Wells and Personal Property to Buyer and that this Bill of Sale shall enure to the benefit of Buyer's successors and assigns; and
  - (c) there are no environmental defects or liabilities associated with or arising from the Wells and Personal Property; and
  - (d) the Oil and Gas Lease under which Seller was operating the Lease is no longer producing oil and gas in paying quantities and as a result has expired under its own terms and conditions.
2. Seller agrees to execute any further documents necessary to complete the assignment of the Wells and Personal Property, including, but not limited to all documents required by the Kansas Corporation Commission to transfer title to the Wells.
3. Buyer agrees to accept all future plugging liability for the Wells.

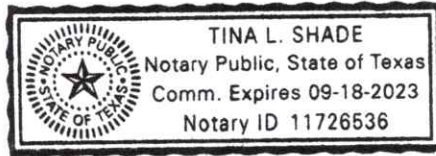

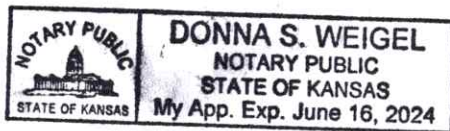
