Phil, here are the wells that they want you to add to a NEW T-1 so the old ones can be processed. Thanks

- Eva Lauber Lease
 - I think the T1 for the Eva Lauber lease should be returned because it is missing four wells, the Lauber #32-C, API #15-207-23767; Lauber #36-C, API #15-207-24347; Lauber #43, API #15-207-26069; and Lauber #43, API #15-207-26069. If those wells are added, then I think the T1 can be processed. However, I don't think we can transfer injection authority for the Lauber #11, API #15-207-02332; and Lauber #5, API #15-207-02335, until Prairie Oil has determined there is either not a well at session points Lau03 and Lau06 identified on the lease field report or if there is a well at those locations, that they are in compliance.
- Degler Lease
 - I think the T1 for the Degler lease should be returned because it is missing two wells, the Degler #9-C, API #15-207-23846 and the Degler #6, API #15-207-01523. If those two wells are added, then I think the T-1 can be processed. However, I don't think we can transfer injection authority for the Deglar #2, API #15-207-02330, until Prairie Oil has determined there is either not a well at session point Deg02 identified on the lease field report or if there is a well at that location, that the well is in compliance.
- Harder Lease
 - I think the T1 for the Harder Lease should be returned because Staff found two wells producing that are not included on the T1, the Harder Estate #4, API #15-207-25121, and Harder Estate #6, API #15-207-25123. Once those wells are added to a T1, then I think it can be processed. However, I don't think we can transfer injection authority for the Harder #2, API #15-207-02205, until Prairie Oil has determined there is either not a well at session points Lau25 identified on the lease field report or if there is a well at those locations, that they are in compliance.


