For Ten Dollars and no/100 (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, together with the performance by Assignee of the covenants, agreements, obligations, indemnities and conditions hereinafter contained, and duly acknowledged by Assignee herein, it is agreed between the parties hereto as follows:



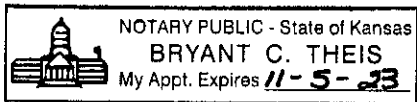
