ASSIGNMENT OF OIL AND GAS LEASE AND BILL OF SALE

KNOW ALL MEN BY THESE PRESENTS, that **JTC Oil, Inc.**, a Kansas corporation, with an address of 35790 Plum Creek Road, Osawatomie, KS 66064, hereinafter called "Assignor" for valuable consideration, the receipt of which is hereby acknowledged, does grant, bargain, sell convey, transfer, assign and deliver unto **Kingman Oil, LLC**, a Kansas limited liability company, with an address of 2394 Utah Road, Rantoul, Kansas 66079, hereinafter called "Assignee" (whether one or more), its successors and assigns, all of Assignor's right title and interest in and to the following oil and gas Lease and personal property:

- (A) Oil and gas Lease described on Exhibit 1 (the "Lease"); and
- (B) all producing, nonproducing, and shut-in oil and gas wells, salt water disposal wells, water wells, injection wells, and all other wells on or attributable to the Lease which are currently listed on Assignor's well inventory filed with the Kansas Corporation Commission; and
- (C) all pumping units, pumps, casing, rods, tubing, wellhead equipment, separators, heater treaters, tanks, pipelines, compressors, dehydrators, gas processing equipment, gathering lines, flow lines, valves, fittings and all other surface and downhole equipment, fixtures, related inventory, gathering and treating facilities, personal property and equipment used in connection with the Lease, lands or personal property located thereupon and all other interests described above; and
