THIS AGREEMENT is entered into for adequate consideration on this 30th day of April, 2024, by and between **Olympic Oil, Inc.**, hereinafter referred to as "Seller", and Premier Oil & Exploration, Inc., (a Kansas corporation) hereinafter referred to as "Buyer".

WHEREAS, Seller owns a .8203125 Working, .0023148 Royalty, and .0205078 O.R. Royalty oil and gas interest in the **Goering J** oil and gas lease located in McPherson County, Kansas, and,

WHEREAS, Buyer desires to purchase said oil and gas working, royalty, and O.R. royalty interest.

1. PURCHASE AND SALE- Seller agrees to sell, and Buyer agrees to purchase, all of the following described property on terms stated in this Contract:
  - A **.8203125 Working** interest in the oil and gas lease of the NE/4 except the north 40acres of Sec. 27-20S-3W as recorded at the McPherson County Register of Deeds in book 206, page 633. (Commonly known as the Goering J Lease)
  - B **.0023148 Royalty** interest in the oil and gas lease of the NE/4 except the north 40acres of Sec. 27-20S-3W as recorded at the McPherson County Register of Deeds in book 206, page 633. (Commonly known as the Goering J Lease)
  - C **.0205078 O.R. Royalty** interest in the oil and gas lease of the NE/4 except the north 40acres of Sec. 27-20S-3W as recorded at the McPherson County Register of Deeds in book 206, page 633. (Commonly known as the Goering J Lease)
2. FINANCIAL TERMS- The total purchase price for the property described in Section 1 above shall be **Three Thousand Dollars(\$3000.00)**, which shall be paid in full upon execution of this contract and proper assignment of the property described in Section 1 above by Seller.

  - d. There are no liens or encumbrances or undisclosed material actual or contingent liabilities of Seller which have an adverse affect of the assets being purchased herein.
5. CONDITIONS AND WARRANTIES- The Buyer hereby affirms it has inspected the subject property being sold and purchased herein. Buyer agrees to accept said property in its current "as is, where is" condition. Seller makes no representations or warranties as to the condition or suitability of property.

7. TIME- Time is expressly agreed to be the essence in the performance of this contract.
