ASSIGNMENT OF WORKING INTEREST IN OIL AND GAS LEASE AND BILL OF SALE

KNOW ALL PERSONS BY THESE PRESENTS:

THAT WHEREAS, the Assignor SPINES EXPLORATION, INC. is the owner of all of the working interest in and to the Oil and Gas Lease described below.

NOW, THEREFORE, the undersigned, SPINES EXPLORATION, INC., hereinafter called Assignor, for and in consideration of Ten (\$10) and More Dollars, the receipt and sufficiency of which is hereby acknowledged, do hereby assign, transfer, convey and set over to RUSSELL OIL, INC., hereinafter referred to as Assignee, all of its right, title and interest, the same being all of the working interest (.8203125 NRI), in and to the following oil and gas lease:

Oil and gas lease dated October 8, 1981, from Rudolph Bollig, et al., Lessors, to Evan G.
