John Thomas d/b/a Vamco Operations and Corey Thomas hereinafter referred to as "Assignors", for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, do hereby grant, sell, convey and assign unto **SPEC Oil & Royalty, Inc.**, hereinafter referred to as "Assignee", all of Assignors' right, title and interest, the same being an **undivided 100% working interest**, (.875000 Net Revenue Interests) in the oil wells, disposal wells, and oil and gas lease described in Exhibit "A", attached hereto and made a part hereof, and the rights, privileges and estates given, created and granted under said oil and gas lease and Salt Water Disposal Well Agreement ("Agreements"), subject to the terms and conditions hereof and the terms and conditions of said Agreements, and further subject to all contracts or agreements, Oil and/or Gas Sales contracts, permits, licenses, easements, surface leases and rights of way relating to operations pertaining to said property and leasehold, together with all of Assignors' right, title and interest in and to the leasehold equipment, material or personal property used exclusively for operations of such assigned leasehold and located thereon, therein or appurtenant thereto, in its present condition. 


