AGREEMENT FOR PURCHASE OF WORKING INTEREST IN OIL AND GAS LEASES

THIS agreement signed this 13<sup>th</sup> day of May, 2024, by and between SCHECK OIL OPERATION as the Operator and representative for Sellers, hereinafter referred to as "Operator", and RODNEY BROWN D/B/A MJT OIL., hereinafter referred to as "Buyer".

WHEREAS, Operator represents the owners of the working interest in oil and gas leases covering the following land in Russell County, Kansas:

Niedenthal South-S/2 SW/4 23-14-15  
Niedenthal North-W/2 NE/4 23-14-15

hereinafter referred to as the "Subject Leases".

Operator represents the Sellers who wish to sell their interest, being all of the working interest, in the Subject Leases to Buyer and Buyer wishes to purchase the same.

IN CONSIDERATION of the above recitals and of the benefits to be derived by each party under this Agreement, it is hereby agreed as follows:

1. Purchase Price. Buyer agrees to purchase the Subject Leases and all rights incident thereto and the personal property thereon for the sum of \$10,000.

2. Payment. Buyer shall pay Operator the purchase price of \$10,000 at sale closing upon delivery of Sellers' Assignments of the Subject Leases.

3. Effective Time. The Effective Time for the sale is May, 2024 at 12:00 o'clock a.m.

4. Sellers' Assignments. Sellers shall convey their interests in the Subject Lease to Buyer free and clear of all liens and encumbrances, but subject to any overriding royalties of record.

5. Property Tax. Sellers will pay all of the 2023 and prior years property taxes, if any, on the Subject Leases. In addition, 2024 property taxes will be prorated between the parties to the Effective Date based on the 2023 taxes and Sellers' share will be credited against the purchase price. Buyer will pay all of the 2024 property taxes when due. If Operator receives the 2024 tax statement, Operator will forward it to Buyer for payment by Buyer.

6. Sale Closing. Sale closing shall occur upon execution of this Agreement. At the Closing the following shall occur:

- a. Sellers shall execute, acknowledge and deliver the Assignments of Oil and Gas Leases which shall convey Sellers' full working interest in the Subject Leases to Buyer.
- b. All lease records in Operator's possession for the Subject Leases shall be delivered to Buyer.
- c. At the Sale Closing and thereafter as may be necessary, the parties hereto shall execute, acknowledge and deliver transfer orders and such other instruments and documents and shall take such other action as may be necessary to carry out their obligations under this Agreement.
- d. Buyer shall pay Operator \$10,000 less credit for Sellers' share of 2024 property taxes.

7. Miscellaneous Provisions.

- a. Sellers will pay all leasehold expenses incurred prior to the Effective Time and Buyer will pay all leasehold expenses incurred on and after the Effective Time.
- b. Sellers shall be responsible for all claims, costs, expenses, and liabilities with respect to the Subject Leases prior to the Effective Time and Buyer shall be responsible for all of such claims, costs, expenses and liabilities first incurred or related to time as of and after the Effective Time.
- d. The designated operator of the Subject Leases as of the Effective Time is MJT Oil.

8. Amendments. This contract shall not be modified except by written agreement of the parties.

9. Governing Law and Time of the Essence. The laws of the State of Kansas shall govern the terms and interpretations of this contract, and time is of the essence regarding all provisions hereof.
