## **ASSIGNMENT OF OIL AND GAS LEASES**

#### KNOW ALL MEN BY THESE PRESENTS:

That Town Oil Company, Inc., aka Town Oil Company, a Kansas corporation, as Assignor, for and in consideration of the sum of Ten Dollars (10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby assign, sell, transfer and set over unto Crawford County Production, LLC, a Kansas limited liability company, as Assignee, all of Assignor's leasehold working interest in and to the Oil and Gas Leases more fully described upon Exhibit A appended hereto, together with all operating and other rights incident thereto, subject to the following terms and conditions:

- 1. Assignee shall assume and be fully responsible for all costs, losses, liabilities, damages and expenses of any nature whatsoever associated with operation of the Oil and Gas Leases assigned, including, without limitation, those arising out of environmental claims or demands concerning pollution or contamination of soil or water, loss of crops or livestock, damage to improvements, and orders of courts and administrative agencies having requisite jurisdiction, regardless of when the claim or demand is made or the actual or alleged cause thereof occurred, and shall protect, defend, indemnify and hold Assignor harmless from and against the same.

Assignor hereby grants to Assignee the power and authority to execute transfer orders for future oil sales and other authorizations necessary to effectuate the purposes of this assignment.
- 4. Property and ad valorem taxes for 2023 shall be prorated as of the effective date hereof.
- 5. This Assignment is made expressly subject to: (a) all royalty, overriding royalty, and other interests of record operating as a burden upon the Oil and Gas Leases assigned; (b) the terms, covenants, and conditions of the Oil and Gas Leases assigned, reference to which is made for all purposes herein; (c) the terms and conditions of a certain Contract for the Sale and Purchase of Oil and Gas Leases executed by Assignor and Assignee on July 28, 2023, the terms of which are incorporated herein and made a part hereof by reference; and (d) the terms and conditions of a certain Assignment of Production Payment dated and effective July 28, 2023 from Assignees to Assignor covering the lands and Oil and Gas Leases subject hereto.
