ASSIGNMENT OF OIL AND GAS LEASE

This Assignment of Oil and Gas Lease is made and entered into this 29th day of April 2024, by Double K Oil, Inc., hereby referred to as Assignor and Harrison Gilliland, hereby referred to as Assignee.

Assignor does hereby assign to Assignee an interest in and to an Oil and Gas Lease dated June 3rd, 2004, by and between Helen M. Kohl, James Kohl, Kenneth Kohl and Ann Pfannenstiel, Co-Trustees of the Helen M. Kohl Trust dated May 22nd, 1995, and Double K Oil, Inc., and filed June 3rd, 2004 at 2:30 o'clock P.M., Book 126, Page 137, Trego County Register of Deeds.

This Assignment is made in regard to the West Half (W/2) of Section Eleven (11), Township Twelve (12) South, Range Twenty-One (21) West of the 6th P.M., Trego County, Kansas (320 Acres), except for 10 acres of the Southwest Quarter (SW/4) around producing well. Total assigned acres approximately 309, more or less.

The Assignee does hereby warrant that it shall perform and fulfill all terms of the Oil and Gas Lease aforementioned with respect to the obligation of Assignee therein, One Eight Royalty (1/8th) to the Landowner with no Overriding Royalty Interests (ORRI) outstanding. Assignee shall perform the following duties and obligations:

Assignor, in consideration of 0 Dollars (\$0) per acre, and of the royalties herein provided (1/8th) Royality to the Landowner with No Overriding Royalty Interests outstanding, and of the agreements of the Assignee herein contained, hereby grants, leases and lets exclusively unto the Assignee for the purpose of investigating, exploring by geophysical and other means, prospecting, drilling, mining and operating for and producing oil, liquid hydrocarbons, all gases, and their respective constituent products, injecting gas, water, other fluids, and air into subsurface strata, laying pipe lines, storing oil, building tanks, and other structures and things thereon to produce, save, take care of, treat, manufacture, process, store and transport said oil, liquid hydrocarbons, gases and their respective constituent products and other products manufactures therefrom, the following described land, together with any reversionary rights and after-acquired interest, therein situated in County of Trego, State of Kansas, described as follows, to-wit:

West Half (W/2) of Section Eleven (11), Township Twelve (12) South, Range Twenty-One (21) West of the 6th P.M., Trego County, Kansas, Except for 10 Acres of the Southwest Quarter (SW/4). Total Assigned Acres 309, more of less.

Subject to the provisions herein contained, this Agreement shall remain in force for a term of One (1) year from this date (called "Primary Term"). Assignee shall be entitled to extend the term for one (1) additional year on the payment of Fifty Dollars (\$50.00) per acre.

Assignee shall pay to Surface Owner a location charge of Five hundred Dollars (\$500.00) per site of drilling operations and Five Hundred Dollars (\$550.00) per site of oil storage usage. In

addition, any and all exploration, drilling, production and maintenance that result in surface disturbance shall entitle owner to compensation commensurate with the economic loss.

Within Three (3) years of commencement of initial drilling operations on the demised premises, Assignee must spud another well within the demised premises. Similarly, the Assignee must spud an additional well with Three (3) years of secondary spudding. If Assignee does not spud an additional well within Three (3) years of the last spudding, the Assignee shall retain a Ten (10) Acre Tract. All other portions of the demised premises not held by producing wells shall be released to the Assignor.

Disposal of Brine shall be subject to secondary negotiations.

Assignor is entitled to review all geophysical tests and analyses thereof affecting the demised premises.

If, during the primary and extended term of this Lease oil and/or gas production has been terminated, or ceased, for a period of six (6) Months (whether continuous and intermittent during a Nine (9) month period), the lease is terminated and Assignee shall surrender premises to Assignor after plugging any non-producing wells in accordance with regulations of the KCC.

Assignee does hereby hold Assignor harmless with respect to all obligations required of the Assignor as Lessee of the aforementioned Lease.




