### SALTWATER DISPOSAL AGREEMENT

AND EASEMENT

THIS AGREEMENT made this <u>20</u> day of June, 2023, by and between Bradley D. Schmitt, a single person, and Randall F. Schmitt Irrevocable Trust, Randall F. Schmitt, Trustee, hereinafter called Lessors, and Blake Exploration, LLC., hereinafter called Lessee,

#### WITNESSETH:

That Lessee, Blake Exploration, LLC., is the owner of the Oil and Gas Lease covering the South Half (S/2) of 10-11S-32W, Logan County, Kansas.

That Lessors, for and in consideration of an annual rental of Three Thousand Dollars -(\$3,000.00) per year, due on June 1, 2023 and on June 1 of each year of the term of this lease, payable to Lessors, an undivided 1/2 interest each, do hereby demise, lease and let unto Lessee, its successors and assigns, the following described real estate, to-wit:

The Southwest Quarter (SW/4) of Section 11, Township 11 South, Range 32 West, Logan County, Kansas,

together with the right of ingress and egress to and from the leased premises, for the uses and term hereinafter set forth:

The term of this lease shall commence June 1, 2023 and continue as long thereafter as Lessee has a need to dispose of the water from the South Half (S/2) of 10-11S-32W, Logan County, Kansas in to the Saltwater Disposal Well on the Southwest Quarter (SW/4) of 11-11S-32W, Logan County, Kansas.

Lessee shall have the exclusive right to use the leased premises and the well located thereon for purposes of and in connection with the injections/disposal of oil field brine and other waste water from adjoining leases owned by Lessee and for such other leases as Lessee needs to dispose of or inject water from, and for the digging of pits; for the erection of tanks and receptacles necessary in receiving, treating and disposing of said brine and waste water, and for the erection of structures, appliances, engines and machinery necessary in connection with the operation of the disposal/injection well. Lessor grants Lessee the right to lay such pipelines as may be necessary to accomplish the purposes for which this lease is executed. Lessee may drill a replacement well or drill, deepen or plug back the well on the above described lease in order to make it suitable for use as an injection/disposal well.

In the event Lessee fails to make any advance rental payment for an annual extension of the term of this lease, the renewal right and option of the Lessee shall nevertheless continue for a period of thirty (30) days from written notice by Lessee to Lessor of Lessor's failure to make the payment, and in the event Lessee makes the annual rental payment within such thirty-day period, such rental payment shall be deemed to have been made prior to the expiration of the preceding term of this lease

and for the extension of this lease for an additional year. If after the Lessor gives the Lessee the thirty (30) day written notice of its failure to make such annual rental payment and the Lessee fails within the thirty (30) day period to make such rental payment, then this lease shall be considered terminated for non-payment of rent. All payments and tenders may be made by draft or check of Lessee deposited in any post office in an envelope with sufficient postage, addressed to Lessor. No change in the ownership of the above described land shall be binding on Lessee until and unless it shall have first been furnished a certified or photostatic copy of the recorded conveyance effecting such transfer of title and a mailing address for future payments.

Lessee shall have the right to use the leased premises and the well for the injection/disposal of such oil field brine and waste water into the substrata of said lands, as is produced from the leases of Lessee located in the immediate area, and any other lease Lessee operates and deems necessary.

Lessor and Lessee agree that Lessee shall not have the right to bring any additional water from other access to leases in the vicinity onto the Southwest Quarter (SW/4) of 11-11S-32W, Logan County, Kansas, without the written consent of Lessors and an agreement in writing allowing additional leases around the disposal well. When the Saltwater Disposal Well is no longer used, Lessee shall then have the right and obligation to plug said disposal well and remove all salvageable equipment from said lease, it being the intent that the disposal well and all the appurtenant equipment is the property of Lessee. Upon termination of this agreement, Lessee agrees to restore the premises to as near the same or similar condition as the surrounding land.

Lessee agrees to pay Lessor for damages caused to or arising out of or incident to the exercise of the rights granted by this lease. Further, Lessee agrees to indemnify and hold Lessor harmless for any and all claims or causes of action or damages of any nature whatsoever attributed to Lessee's operation of this disposal well. Lessee shall bury its pipelines below plow depth.

Lessee shall have the right, during the term of this lease and any renewal thereof or within sixty (60) days thereafter, to remove from the leased premises all materials, equipment and other personal property placed thereon by Lessee.

Lessee, in operating the injection/disposal well, shall not inject the brine or other waste water into fresh water bearing sands or strata.

Lessor hereby grants Lessee an easement over and across the following described land:
