

LAND EXCHANGE AGREEMENT

This Agreement is entered into by and between Timothy B. Welton and Terrie L. Welton, husband and wife, and Brian B. Barlow and Kathi A. Barlow, Trustees of the Barlow Family Living Trust dated June 26, 2017, and any amendments thereto.

In consideration of the mutual covenants set forth below and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Timothy B. Welton and Terrie L. Welton, husband and wife, and Brian B. Barlow and Kathi A. Barlow, Trustees of the Barlow Family Living Trust dated June 26, 2017, and any amendments thereto, agree as follows:

1. EFFECTIVE DATE – The effective date of this Agreement is July 25, 2024.
2. EXCHANGE OF PROPERTY –
 - a. Timothy B. Welton and Terrie L. Welton own the following property:
The South Half of the Southwest Quarter of Section 31, Township 34 South, Range 11 East of the 6th P.M., Chautauqua County, Kansas.
 - b. Brian B. Barlow and Kathi A. Barlow, Trustees of the Barlow Family Living Trust dated June 26, 2017 own the following property:
The West Half of the Southwest Quarter of Section 23, Township 34 South, Range 14 East of the 6th P.M., Montgomery County, Kansas.
 - c. The parties agree that the exchange lands are of equal value based upon each being an eighty-acre tract priced at \$3,000.00 per acre.
3. CLEAR TITLE – Both parties will ensure that their respective tract will transfer free and clear of all liens or encumbrances.
4. TAXES – Both parties agree that they will assume the real estate taxes for their newly acquired land without any prorations.
5. OIL & GAS – Timothy B. Welton will be responsible for filing all documents transferring any oil and gas operations from the Barlow’s to the Welton’s within 30 days.
6. EXPENSES – Each party will be responsible for all charges related to the land they are acquiring. Charges will include title insurance, preparation of documents, recording of documents, and any other fees owed to Chautauqua Hills Abstract & Title, Inc.
