

This assignment is made and executed and delivered without warranty of any kind and no warranty shall be implied.

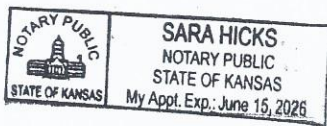
