Together with the same interest in all of the wells and equipment located thereon and used in connection therewith, as well as all oil in stock tanks.

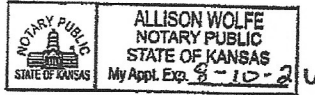
The Assignee assumes all regulatory obligations, including the obligation for the ultimate plugging of wells.
