## ASSIGNMENT OF OIL AND GAS LEASE AND BILL OF SALE

- (A) Oil and gas leases described on Exhibit A (the "Leases"); and

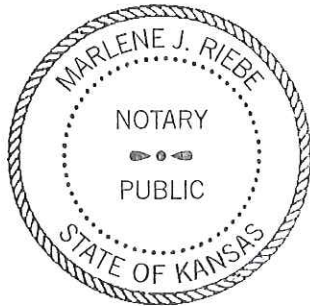
